- LLC Member Statement (if LLC)
- Passport of all the signers on the account
- Tax Identification Number

Documents required

- Copy of passport and/ or visa
- New account information sheet
- W8 or W9 form (non resident and resident account)
- \$100 minimum deposit

Optional: debit card overdraft notice & consent

Apply for a credit card with no credit history

Minimum Requirements:

- Visa (valid for at least one year)
- Social Security Number
- US Income (minimum \$36K)



Documents required:

- Copy of passport and working visa
- Credit card application
- Employment verification form signed by HR manager
- Letter of reference by a foreign bank
- Automatic payment authorization form. This form enables a monthly automatic payment of the credit card balance due, from your checking account to your credit card.


